1. PRESIDENT'S WELCOME & APOLOGIES (T. Weber)

The ESH President, T. Weber, welcomed all members to the ESH Council meeting. He informed the participants that this Council Meeting will be in a shorter format.

T. Weber apologized on behalf of the Council members A. Januszewicz, G. Mancia, J. Polonia who, due to previous commitments, were unable to attend the meeting.

2. APPROVAL OF MINUTES - ESH SCIENTIFIC COUNCIL MEETING ON FEB 8, 2025 (C. Delles)

The minutes of the Council Meeting held on February 8, 2025, in Milan, Italy, were approved unanimously by the Council members.

3. TREASURER'S REPORT

3.a ESH Financial Report (J. Danser on behalf J. Polonia)

J. Danser, the incoming ESH Treasurer, reported on the financial status, provided by ORNITAG at 31 December 2024 vs 31 December 2023, in Swiss francs and audited.

- Previous year's income is higher due to the Berlin Meeting.
- Expenses for services increased but mainly due to the contribution to FESH. Without it, expenses are lower by some CHF 17,000.
- There were also lower "operating expenses", and a financial income of CHF 66,000 vs a loss of CHF 102,000 in the previous year.
- A stable EUR/CHF exchange rate and a gain in USD/CHF as well as the purchase of CHF at higher rates helped a lot.
- ESH also received interest on EUR monies invested in time deposits.
 - Net assets at beginning of period: **2024**: 1,992,000.75 / **2023**: 1,994,190.35
 - Profit/Loss (net results for the year): 2024: 141,870.88 / 2023: -2,189.60
 - Net assets at end of period: 2024: 2,133,871.64 / 2023: 1,992,000.75
 - Total INCOME: 2024: 417,697.78 / 2023: 298,676.84
 - Total EXPENDITURES: 2024: 275,826.90 / 2023: 300,866.44

The problem of unpaid membership fees and how to overcome it was discussed. The Membership Task Force will brainstorm and report on the outcome at the next Council meeting.

3.b FESH Financial Report (M. Burnier)

M. Burnier reported on the general financial situation of the FESH.

- New research projects (e.g. with AstraZeneca) providing new income for the Foundation, which will handle the expenses of the projects.
- Excellent results of the Summer School in France; 60% of the costs were covered by sponsorship. Many thanks to Atul Pathak for his efforts.
- Good entries from webinars and other seminars.
- Positive financial income due to a favorable exchange rate.
- Less administrative costs.

 - Total Foundation capital: 2024: 466,438.48 / 2023: 362,809.32
 - Total liabilities: 2024: 914,033.73 / 2023: 687,456.91

4. BUSINESS MATTERS

4.a Reminder By-Law Changes (C. Delles)

C. Delles reminded the Council on the planned changes to the ESH By-Laws, already discussed during the previous Council meeting.

The amendments only affect § 15 of the current statutes. C. Delles always presented the current passage in comparison to the amended passage.

§ 15.a Composition of ESH Scientific Council

<u>OLD</u>

The ESH Scientific Council is formed by 11 elected voting members (including Office Bearers), by nonvoting Ex-Officio Members and by non-voting Executive officers nominated by the Scientific Council for specific matters.

NEW

The ESH Scientific Council is formed by the **Nucleus** (6 Office bearers and 5 additional elected voting members), by non-voting Ex-Officio Members and by non-voting Executive Officers (Task Force leaders) nominated by the **Nucleus** of the Scientific Council for specific matters.

§ 15.b Election of ESH Scientific Council and terms of service

ESH Scientific Council members shall be elected as follows: at the time of the General Assembly during the Annual Scientific Meeting of the ESH, the Society shall vote on membership of the **Nucleus** of the ESH Scientific Council, giving due consideration to the recommendations of the existing Scientific Council. Any member of the Society may nominate a candidate by writing to the Secretary of the ESH Scientific Council not less than sixty days before the scheduled Annual Scientific Meeting of the ESH.

<u>OLD</u>

Members of the Scientific Council may serve for a **four-year** term with the possibility for an additional **four-year** term depending on the confirmation by the General Assembly.

<u>NEW</u>

Members of the Nucleus of the Scientific Council may serve for a **three-year** term with the possibility for an additional **two-year** term depending on the confirmation by the General Assembly.

§ 15.c Duties of ESH Scientific Council

<u>OLD</u>

The presence of six elected members of the ESH Scientific Council constitutes a quorum.

NEW

The presence of six elected members of the **Nucleus** of the ESH Scientific Council constitutes a quorum.

<u>OLD</u>

The ESH Scientific Council should normally meet at least **twice a year**. Meetings should be convened by the ESH President. Additional individuals may be invited by the President to participate in an ESH Scientific Council meeting.

<u>NEW</u>

The **Nucleus** of the ESH Scientific Council should normally meet **at least every other month** (virtual meetings possible; at least 2 in person meetings per year). Meetings should be convened by the ESH President. **Additional members of the Scientific Council** (and other individuals) may be invited by the President to participate in an ESH Scientific Council **Nucleus** meeting.

§ 15.d Office Bearers

<u>OLD</u>

Office Bearers of the Society are:

- the President,
- the Immediate Past President,
- the Vice-President,
- the Secretary,
- the Treasurer and,
- the Officer at Large

<u>NEW</u>

Office Bearers of the Society are:

- the President,
- the Immediate Past President,
- the Vice-President,
- the Secretary,
- the Treasurer and,
- the Young Investigator Representative

With this amendment to the By-Laws, the position of the Officer at Large will be abolished, while the Young Investigator Representative will be a newly established position.

§ 15.d Office Bearers

<u>OLD</u>

The President shall serve for a two-year term and shall subsequently remain in the ESH Scientific Council as Officer Bearer for two more years as Immediate Past President. This applies also when the total period of the Immediate Past President in the Scientific Council exceeds eight years.

The Vice-President shall normally serve or two years with the possibility for an additional two-year term, but without extension of a maximum eight-year term in the Scientific Council.

<u>NEW</u>

The President shall serve for a two-year term and shall subsequently remain in the Nucleus of the ESH Scientific Council as Office Bearer for two more years as Immediate Past President. This applies also when the total period of the Immediate Past President in the nucleus of the Scientific Council exceeds eight years.

The Vice-President (President-Elect) shall serve for two years, and shall then become President, and subsequently Immediate Past President. This applies also when the total period of the Immediate Past President in the Nucleus of the Scientific Council exceeds eight years.

The Secretary, the Treasurer, the Young Investigator Representative shall normally serve for three years with the possibility for an additional two-year term, but without extension of a maximum eight-year in the Nucleus of the Scientific Council.

The Young Investigator Representative should be elected by the Young Investigator Group and should be typically at an earlier career stage.

§ 15.e Ex-Officio Members

<u>OLD</u>

Ex-Officio non-voting members of the Scientific ESH Council are:

- One ESH member representing FESH.
- One ESH member representing the affiliated and associated National Hypertension Societies.

The ex-officio member shall serve for a two-year term with the option to prolong this term for additional two-year period.

NEW

Ex-Officio non-voting members of the Scientific ESH Council are:

- One ESH member representing FESH.
- One ESH member representing the affiliated and associated National Hypertension Societies.

The ex-officio member shall serve for three-year term with the option to prolong this term for on additional two-year period.

§ 15.f Executive Officers

<u>OLD</u>

The ESH Scientific Council may appoint Executive Officers with specific responsibilities in areas that are regarded by the ESH Scientific Council to require expert attention and decisions on a continuous basis. They can be selected from among ESH Scientific Council members or regular ESH members on account of experience and competence. Executive Officers selected from regular ESH members may be invited by the ESH President to attend the ESH Scientific Council meeting or a portion of the meeting. Areas to be considered for Executive appointments are:

- Coordination of Working Group Activities
- ESH Summer Schools
- Educational Activities of the Society
- Research and Communication Activities of the Society
- Liaison with other (non-European) International Hypertension Societies or Scientific Bodies
- Young Fellows
- General Practitioners Network
- eHealth Technologies

NEW

The ESH Scientific Council may appoint Task Forces, led by Executive Officers, with specific responsibilities in areas that are regarded by the ESH Scientific Council to require expert attention and decisions on a defined time span or on a continuous basis. They can be selected from among ESH Scientific Council Nucleus members or regular ESH members on account of experience and competence. Executive Officers, leading Task Forces, selected from regular ESH members may be invited by the ESH President to attend the ESH Scientific Council Nucleus meeting or a portion of the meeting. Areas to be considered for Executive Officer appointments can be defined by the Nucleus of the Scientific Council at any time, typical examples being:

- Coordination of Working Group Activities
- ESH Summer Schools
- Educational Activities of the Society
- ESH Conference Planning Coordination

- Guidelines Preparation
- Research and Communication Activities of the Society
- Liaison with other (European and non-European) International Hypertension Societies or Scientific Bodies
- General Practitioners Network
- eHealth Technologies

The Executive Officers (Task Force Coordinators) shall serve for the time period to fulfill the task given. The maximum duration is 6 years.

Following the presentation of the proposed amendments to the ESH By-Laws, a discussion took place covering several key points. The main issues raised were:

- Concern that the new By-Laws were not circulated to all members prior to the General Assembly, which was considered non-constitutional.
- The need for a transition phase to address and clarify several crucial aspects, including:
 - The election of a new Vice-President
 - A clear definition of the Vice-President's role
 - The organization of next year's elections
 - A clear definition of term limits and mandates

The result was that there was no consensus within the Council on the changes described. The amendments need to be discussed in detail once again. The only change that was decided upon was the introduction of the position of Young Investigator Representative and the abolition of the position of Officer at Large in the Council. This change will also be presented during the General Assembly on Sunday, May 25, 2025 in Milan.

4.b Reminder new Office Bearers, Elected Members (C. Delles)

The Council members were reminded that the term of the current ESH Treasurer Jorge Polonia will end in June 2025. The proposed new candidate is Jan Danser.

His nomination was already confirmed during the Council meeting in February 2025. The official confirmation will be made during the General Assembly in Milan.

With the agreed amendment to the By-Laws, it was decided to abolish the position of "Officer-at-Large". This means that the original number of 6 Office Bearers will be reduced by one member. To compensate for this, the position of a Young Investigator Representative will be established. The number of 6 Office Bearers is thus again achieved. Consequently, Michael Doumas will no longer be an Office Bearer but will remain in the Council as an elected voting member.

The Young Investigators Nucleus group unanimously nominated Diana Ferrão (Portugal) as candidate for the position of Young Investigator Representative on the ESH Council. The ESH Council had no objections.

After the General Assembly has confirmed the small amendment to the By-Laws and the mentioned changes of officers, the ESH Council members that are eligible to vote are:

4.c Membership Status (C. Delles)

C. Delles presented the current Membership status at May 15,2025.

- Total number of ESH members = 2,583

 - 25 from non-European countries (Africa, Asia, Middle East, Oceania, North & South America)
 - 19 participants from the ESH 2024 Summer Schools
- Paid/renewed 2025 membership fees = 269
 - Standard fees paid (Euro 100) = 259
 - Reduced fees paid (Euro 50) = 10
 - ESH Scientific Council members / other Committee members = 15
 - 2024 membership fees paid in 2025 = 16

A discussion took place on the ongoing challenge of encouraging members to pay their membership fees and on possible strategies to improve payment rates. The Task Force will meet to explore this further and report back with recommendations.

5. UPDATE GUIDELINES

5.a + b ESH MASTERplan Activities (R. Kreutz)

R. Kreutz reported about the current situation with the Publisher Wolters Kluwer. The collaboration is increasingly problematic since the publication process is excessively long and everything incurs a cost. Translations into other languages are not possible. This overall situation is becoming unacceptable.

R. Kreutz suggested the following procedure:

- Consider updating the MASTERplan publication separately in Blood Pressure 2025 retaining all copyrights for ESH (print, translation, full freedom of use (e.g. on website, presentations, etc.).
- The figure in MASTERplan created by R. Kreutz & A. Januszewicz is currently copyrighted by Wolters Kluwer.
- Generate new graphics/Tables for which Wolters Kluwer currently has the copyrights.

M. Burnier mentioned that Ornitag can always be asked to check contracts with new publishers. This opportunity should be taken into account.

It was concluded that completely new figures will be done before the summer break. The new versions can then be published in Blood Pressure. Any volunteers are welcome to help.

5.c Joint Paper (T. Weber)

T. Weber informed the Council that the Joint Paper *European guidelines for hypertension in 2024: key recommendations for clinical practice* has been accepted for publication in Nature Reviews Cardiology.

6. ESH EXCELLENCE CENTRE & HYPERTENSION SPECIALIST PROGRAM (M. Doumas, C. Delles)

M. Doumas reported on the current status of the ESH Excellence Centres at May 21, 2025.

M. Doumas reiterated the ongoing issue of unpaid membership fees. He informed the Council members that when the Heads of an E.C. are not in good standing, the E.C. is removed from the Directory on the ESH website until payment is received.

He informed the Council that when there is a change in the Head of an E.C., the incoming Head must submit a new application detailing the updated leadership and any changes since the original submission.

He also informed the Council that a series of webinars involving the E.C.s is scheduled to begin in September.

6.b ESH Hypertension Specialists Update

M. Doumas reported on the current status of the ESH Hypertension Specialists at May 15, 2025.
